

# 2 Year Warranty Portable Marine Fuel Tanks

### Limited Warranty

Seller warrants to Purchaser for a period of up to 2 years from the date of purchase that your Moeller Portable Marine Fuel Tank will be free from defects in materials and workmanship. This warranty applies to normal recommended use and service of the Tank, and misuse or abuse of the Tank resulting in damage to or destruction of the Tank is expressly excluded from, and will void, this Limited Warranty. No other express warranty is made with respect to the Tank. Seller's sole obligation under this Limited Warranty, and Purchaser's sole remedy, shall be to repair or replace, at Seller's option, any defective parts returned to Seller with Seller's approval, freight collect, within 2 years from the date of purchase. Any liability of Seller to Purchaser arising out of or in connection with the sale, delivery or use of the Tank shall not, in any case, exceed the purchase price of the Tank.

#### **Disclaimer of Certain Damages; Limitation of Implied Warranties**

SELLER SHALL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES IN ANY MANNER ARISING FROM OR PERTAINING TO THE TANK OR THROUGH ITS INTENDED USE. THE DURATION OF ANY IMPLIED WARRANTIES, INCLUDING WITHOUT LIMITATION THE IMPLIED WARRANTIES OF MERCHANTABILITY AND OF FITNESS FOR INTENDED USE, IS EXPRESSLY LIMITED TO THE TWO-YEAR WARRANTY PERIOD APPLICABLE TO THE EXRRESS LIMITED WARRANTY PROVIDED HEREUNDER.

## **Return Goods Authorization Number**

All return products require a "Return Goods Authorization Number" ("RGA"). An RGA number can be obtained by: • calling 800,432.8344

Return products must be sent to the following address, freight collect, and otherwise in accordance with instructions given with the RGA number:

Moeller Marine must be notified in writing within 10 business days of the expiration of the warranty period at the above email address of a potential warranty claim involving a Tank, and failure to provide such notice will void this Limited Warranty.

## **Return of Goods; Freight Cost**

Moeller will designate and contact the freight carrier for the return of a defective Tank. Moeller will only accept freight on a collect basis. If the Tank is not determined to meet the warranty criteria, the customer may be charged back the freight cost.
